Mr Morrell spoke of the street light being removed and possibly a new one installed at Upper Lea. None of the residents in this area saw the need for another street light in this area.

Mr Shipman spoke of his concern regarding the planning application AVA/2007/0045 Poly tunnels and shed on land at Lea Road Lea Bridge. He had many concerns and asked for the Parish Council to please consider this application very carefully. A parishioner had reported some type of guns being fired in woods in Holloway.

There was also a report that the utilities had dug up the entrance to little London and have left the trench very rough and not covered over with tarmac.
